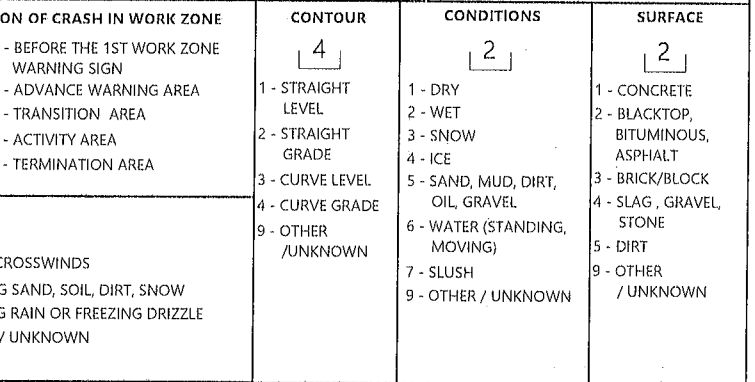

NARRATIVE
On 8/14/2022 at 1130 hours, I was dispatched to 3944 SR 222 in Batavia Twp for a crash report. Upon arrival, I spoke with Autumn Stamper who was driving the blue Chevrolet minivan with the Ohio registration of JOA9267 (Unit 1). Ms. Stamper advised she was trying to slow down in order to make the turn at this location but was going too fast. 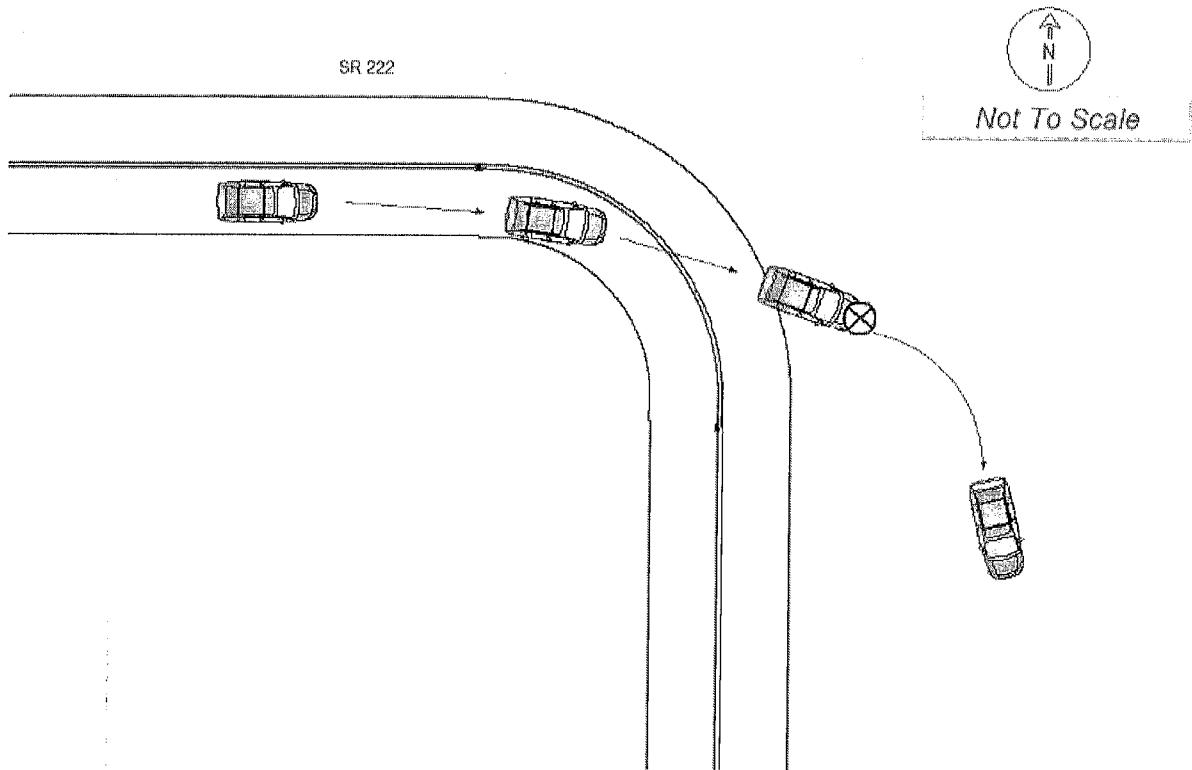
