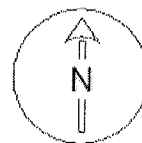

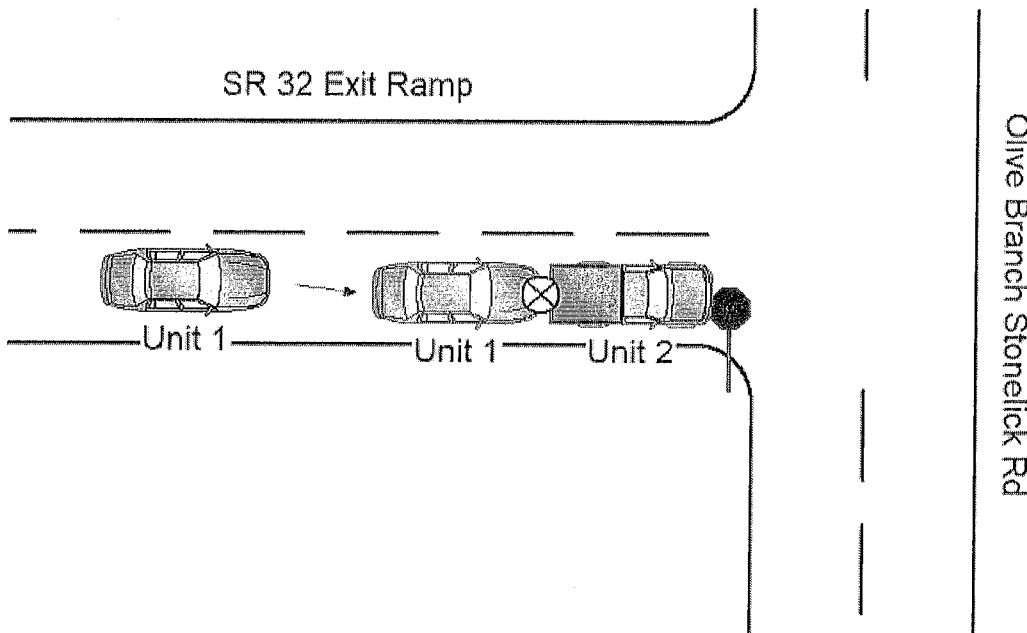
ACCIDENT LOCATION
