

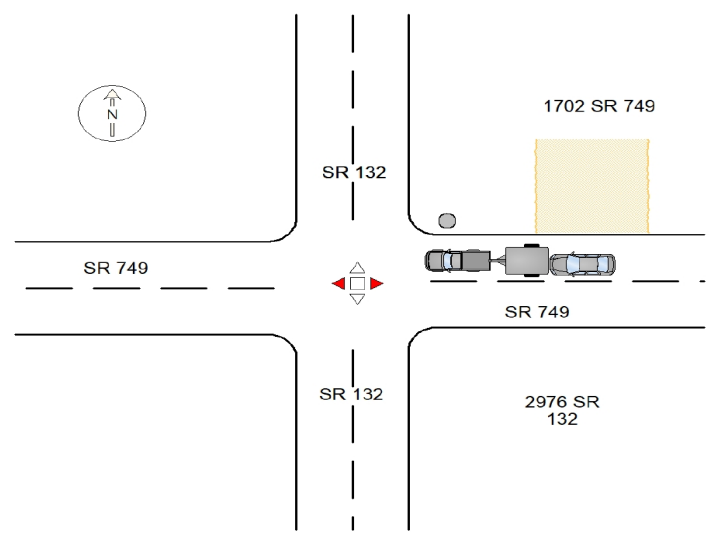

The caller, Ms. Tiffany Wade advised she was the driver at fault. Tiffany further advised that she is sitting in her white Ford Focus at the scene. Upon my arrival, I made contact with Tiffany and observed her husband's (Aaron Wade) white Ford Focus bearing Ohio Registration GRV5100 parked WB SR 749 near the SR 132 intersection with the hazard lights activated. Tiffany advised that she was behind a truck and trailer at the the red light. Tiffany advised she observed the truck move forward so she proceeded to move and that is when she struck the back of the trailer. Tiffany advised that the driver of the truck pulled into a nearby parking lot. I advised Tiffany to pull her vehicle in a nearby parking lot to clear up traffic. I observed damage to the front of hood on Tiffany's vehicle. I photographed the scene and damage on Tiffany's vehicle. I gathered Tiffany's information and sent her on her way. I responded over to 2976 SR 132 (Lindale Auto Parts) and made contact with Mr. Justin Troxell and his family. Justin was operating his blue Chevy Silverado truck bearing Ohio Registration JFY4942 and pulling a silver trailer bearing Ohio Registration SZA4193.

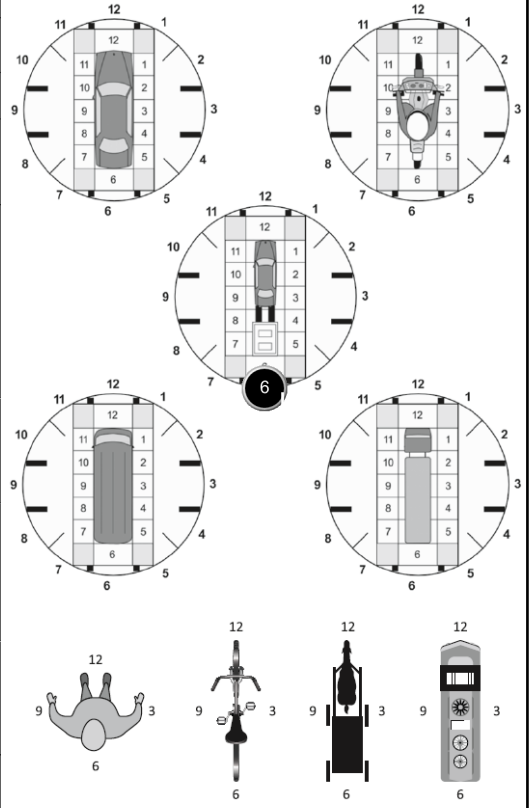

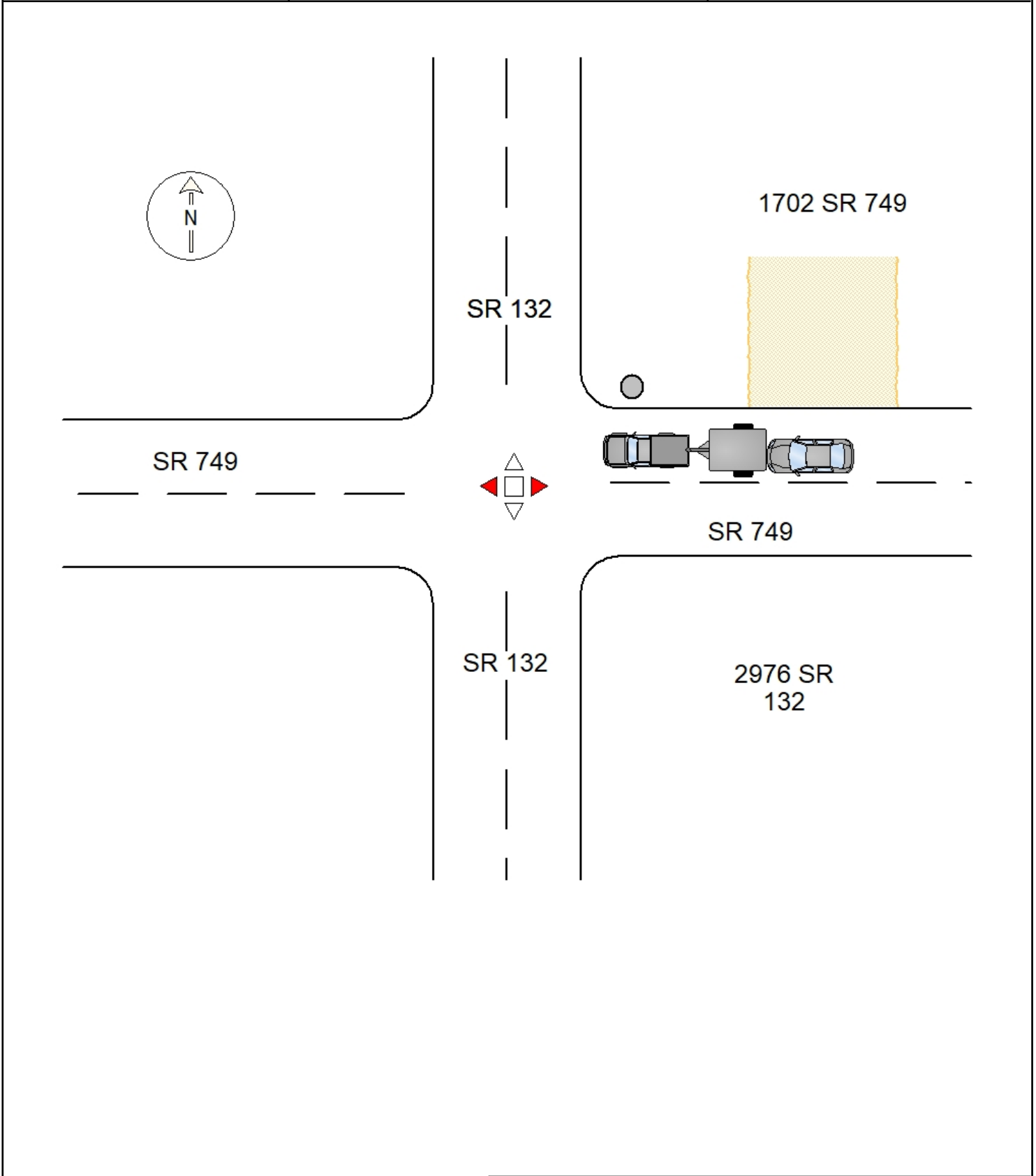
