

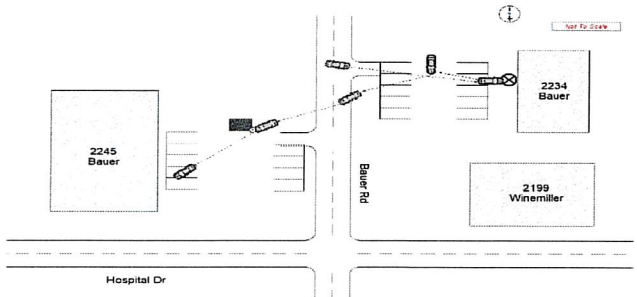

Upon arrival to the scene I observed a white KIA Sorento with heavy front-end damage and airbags deployed in the parking lot of 2245 Bauer Rd. The driver was identified as Mr. Dominic Neusbaum. There were tracks both in a large grass lot and the pavement in the parking lot of 2245 Bauer Rd. which led back to the parking lot at 2234 Bauer. Along with the tire tracks there was also a large amount of white debris from the KIA strewn about the path it had taken. I followed the tracks to their origin at 2234 Bauer where I observed the Papa John's at the address with its front door and windows shattered and pushed inwards. Witnesses at the scene identified the KIA and Mr. Neusbaum as the driver and vehicle which had struck their establishment moments before. Mr. Neusbaum was subsequently charged with OVI and hit-skip and was transported to Clermont Mercy Hospital.

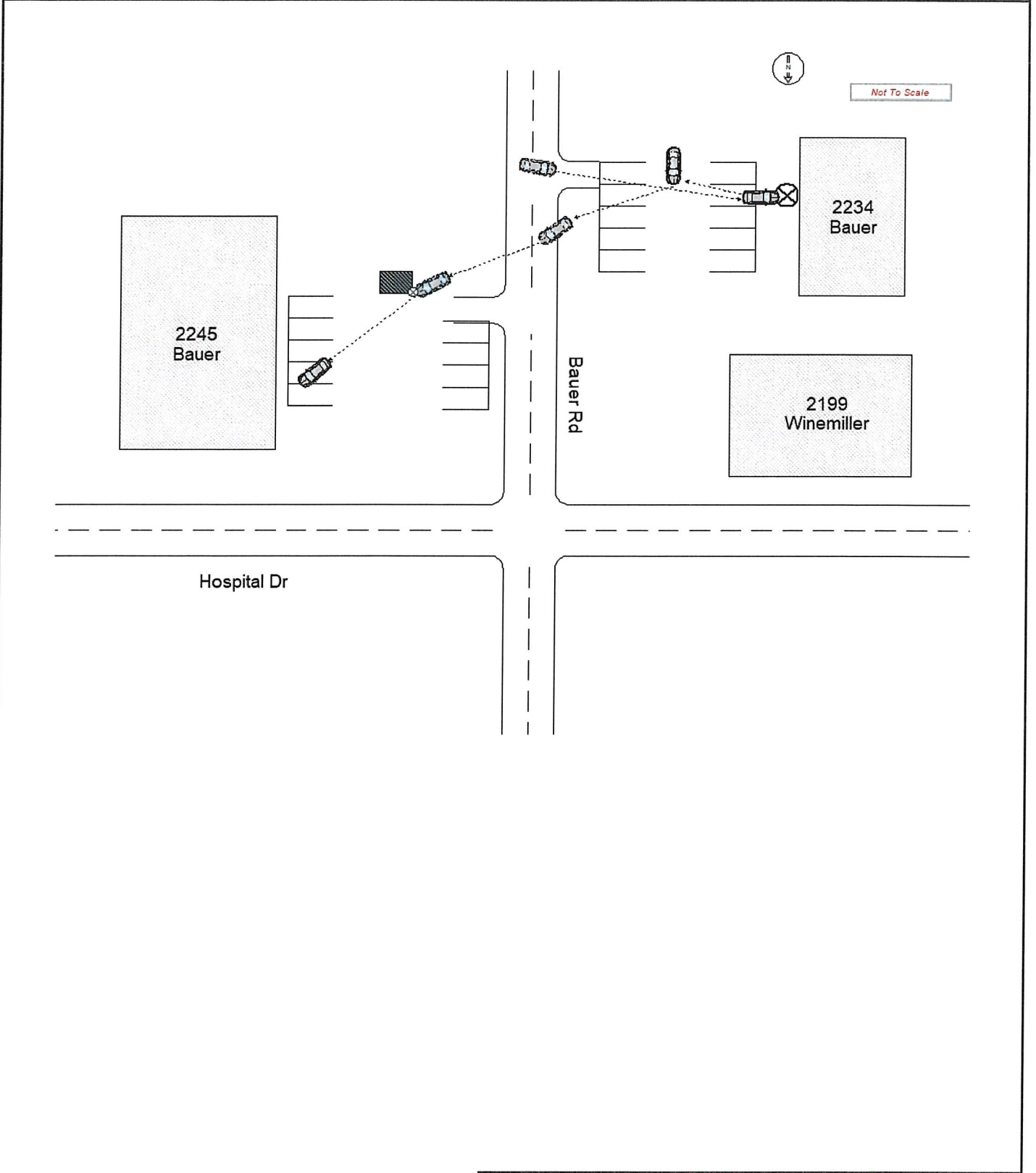
