Ms. Maher stated she swerved and eventually lost control of the vehicle due to the slick roads. Ms. Maher advised she was traveling at approximately 30 to 35mph. The posted recommended speed for negotiating the curve on Clough Pike is 25mph. After leaving the roadway, the vehicle struck a guy-wire before stopping at the brush line. The impact with the guy wire caused the wire/mount to become unsecured from the residence of 1483 Clough Pike. The power was still on and Duke was notified.

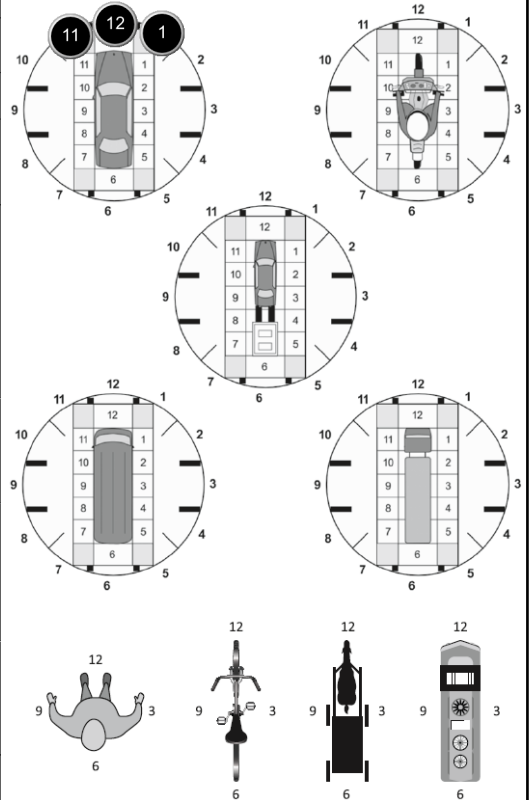

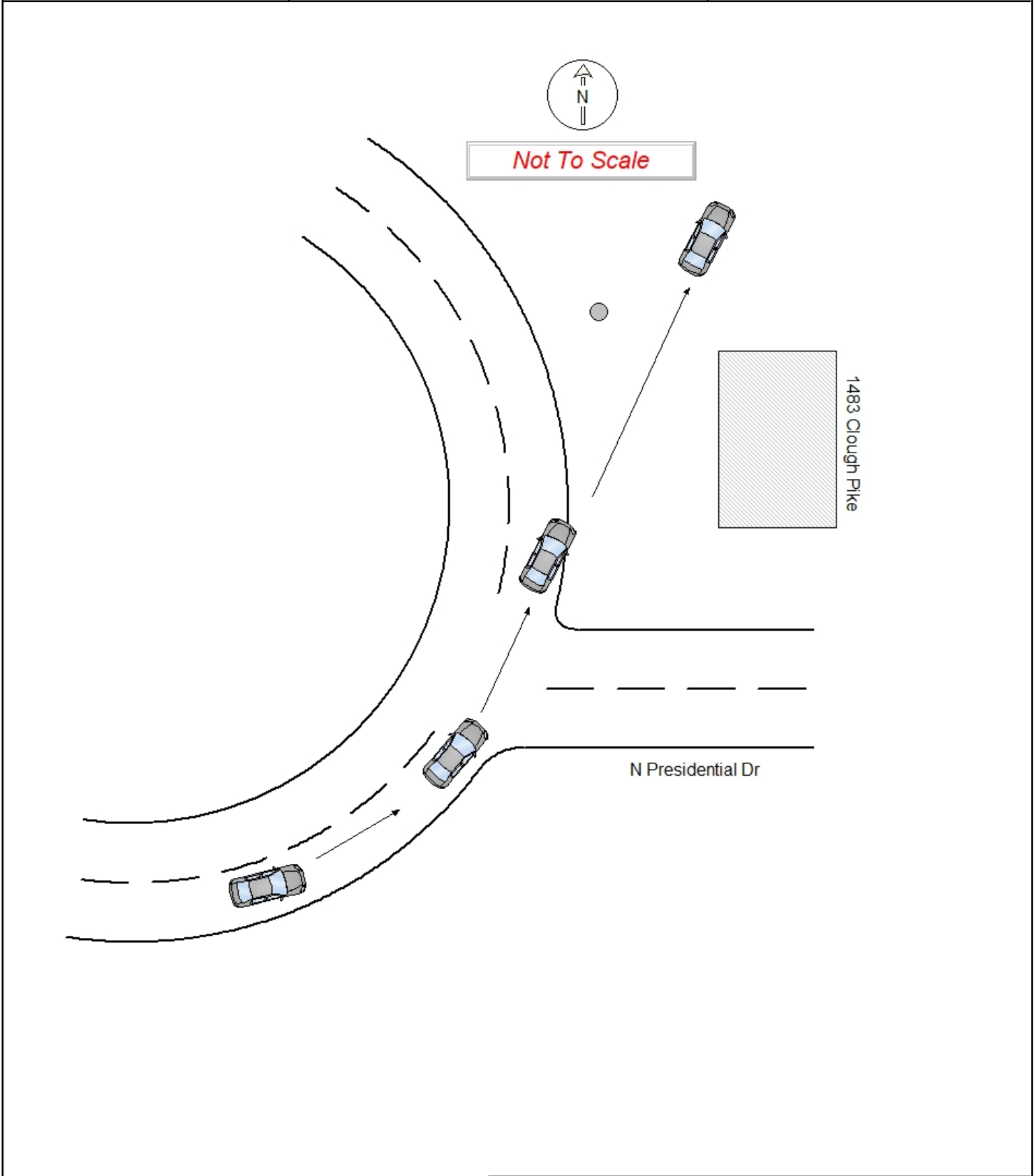
