NARRATIVE											
On April 5th, 2023, at 0009 hours I was dispatched to the area of 4114 Zagar Rd., Batavia Township. Dispatch advised the caller stated they struck some sort of rope/chain object across the road and the subjects at this residence stated they were not using the chain and had left the scene. When I arrived on scene, I made contact with the driver of Unit 1, Mikayla Sears, and the passenger, Bethany Sears. They advised a green truck that was now parked at the above residence was stopped in the road with no hazard lights on. They advised Mikayla began to slow down and they observed a chain or rope across the road hooked to the truck and the line was taut. They advised they struck the item and the two males began moving the item and stating they were not using it. They advised one male walked down the road and the other male went into the residence. I attempted contact at the residence with no answer. I observed damage along the front and front drivers side of the front bumper consistent with a chain being the item struck.

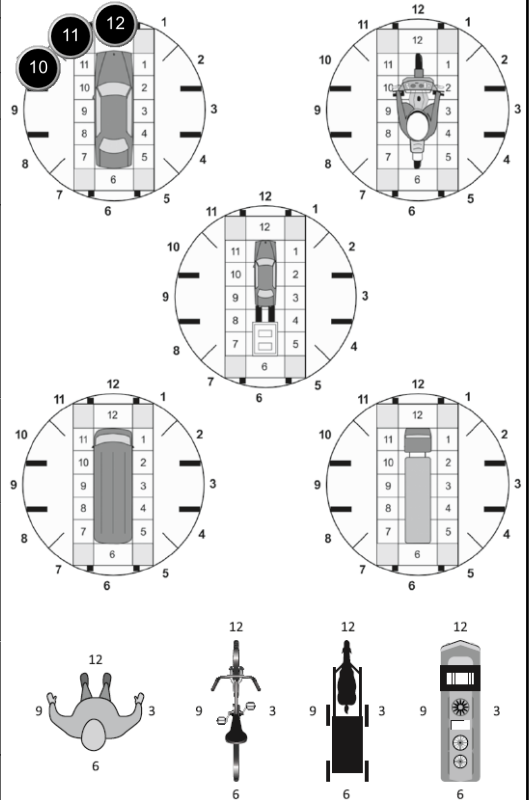

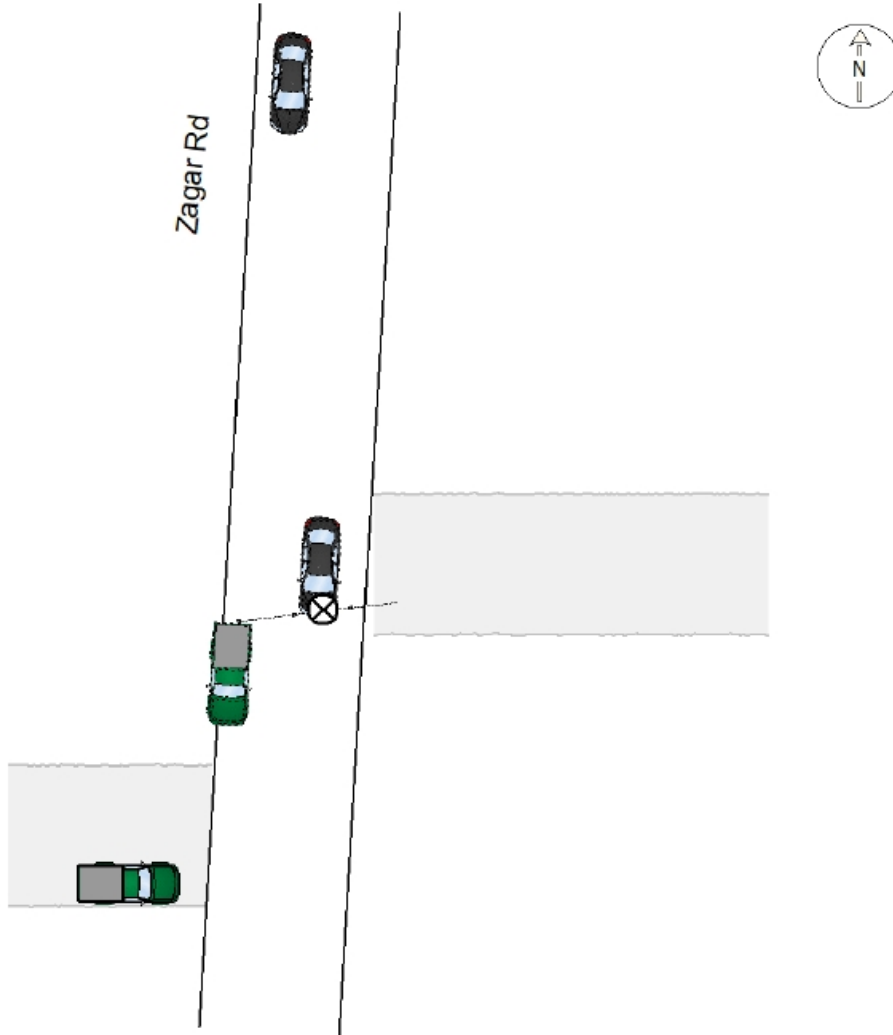
