Photographs were taken of the scene and both drivers advised that they were wearing there seat belts. Driver of unit #1 advised that he was not injured and when I asked the driver of unit #2 she advised that she was not injured, but her neck was getting sore. Driver of unit #1 was issued a citation for right away at an intersection. Driver of unit #1 did not need a tow truck, but Grays towing responded and towed unit #2 away from the scene.

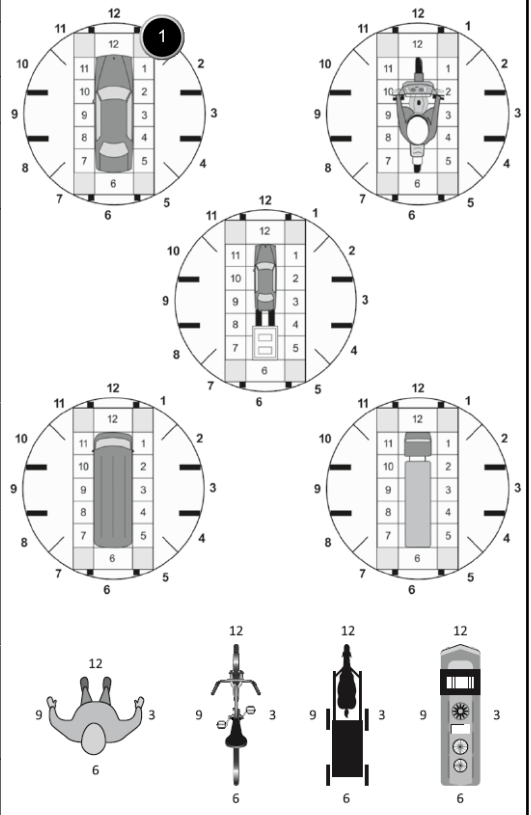

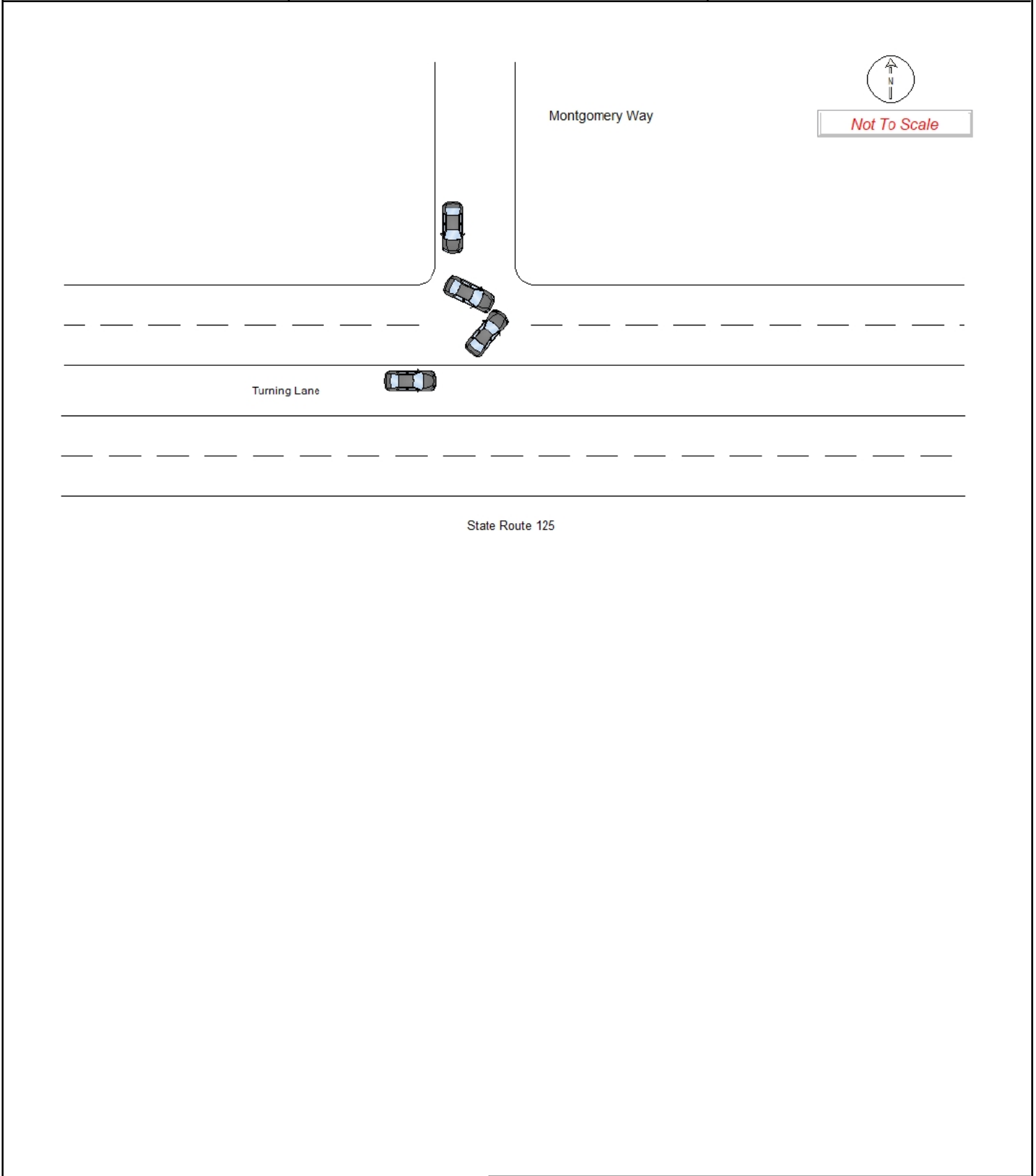
