Driver of unit #2 advised that he did have his turn signal on and was waiting on a vehicle to pass so he could turn left onto Ninnichuck Road. Driver of unit #1 advised that when he came over top the hill he noticed unit #2 stopped waiting to turn and he just could not stop in time. Both drivers advised that they were not injured and that they were both wearing their seat belts. Photographs were taken of the damage to both vehicles and the driver of unit #1 issued a citation for ACDA.

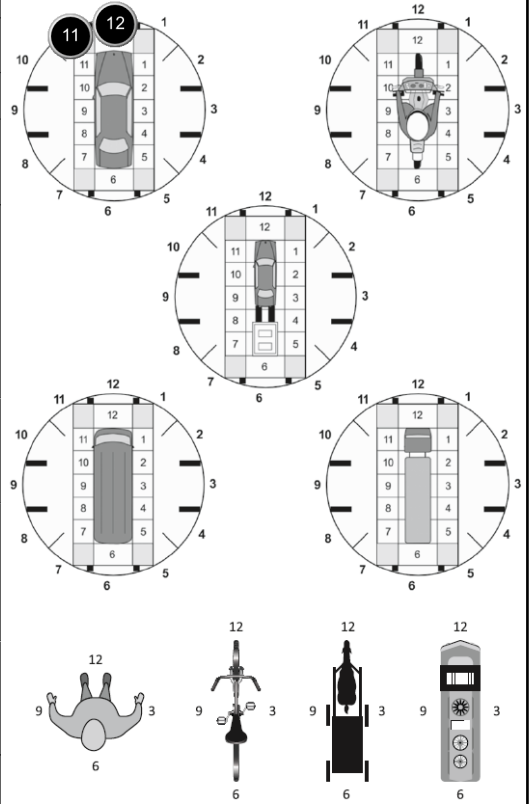

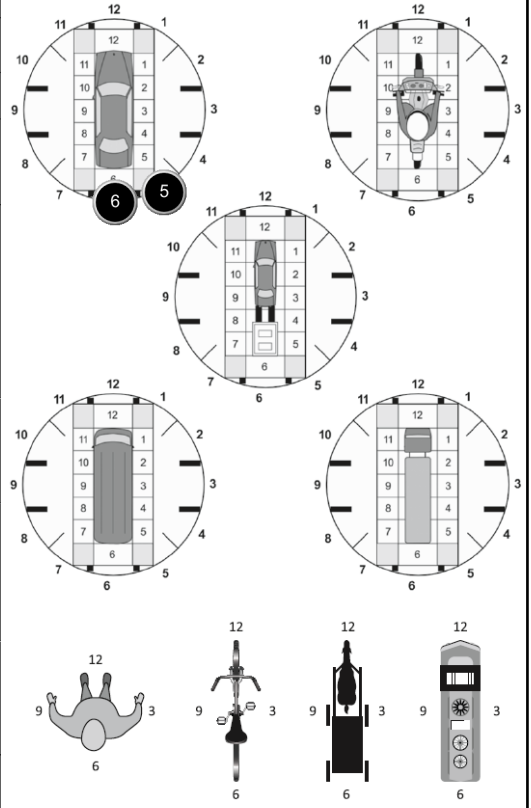

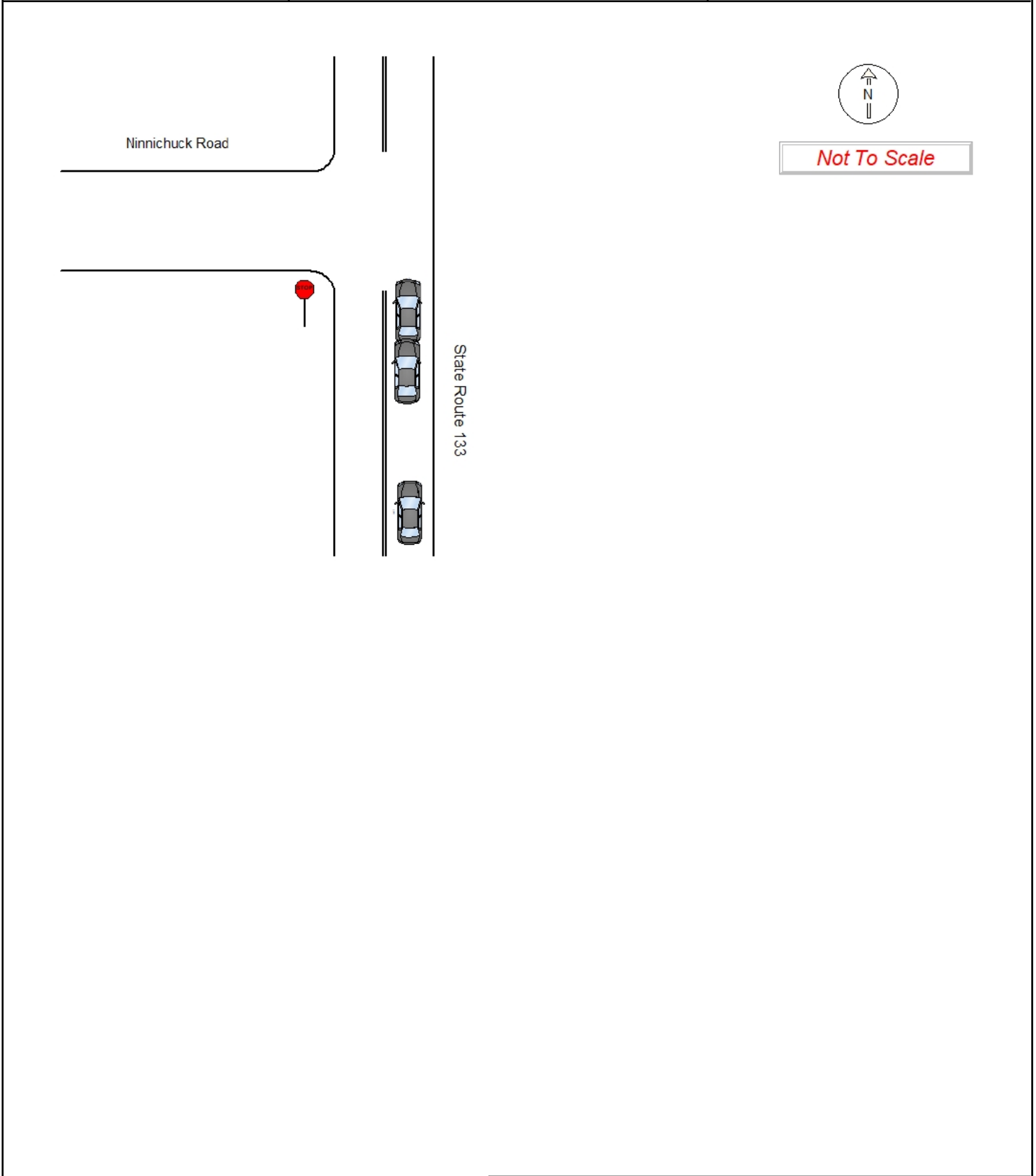
