

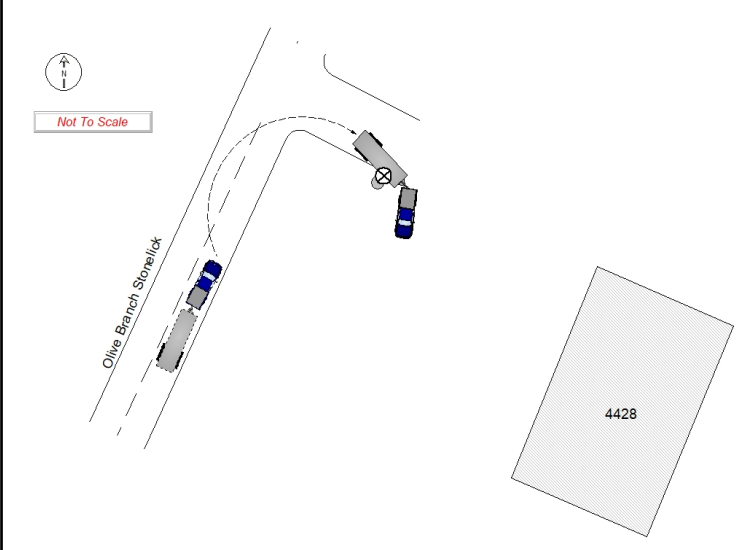

Upon arrival the store owner, Sandeep Patel, advised he had video footage of a truck and trailer striking a light pole in the business lot and leaving without contacting the store. The pole was now leaning from the incident and a black scrape was along the concrete base. I observed the video and a truck bearing PID3600 was towing a long black trailer and is seen swiping the base of the light. I contacted the owner of the truck Jonah Development Corp. and spoke with the driver Dennis Coleman. Mr. Patel advised he and Mr. Coleman would work out payment for the damages.

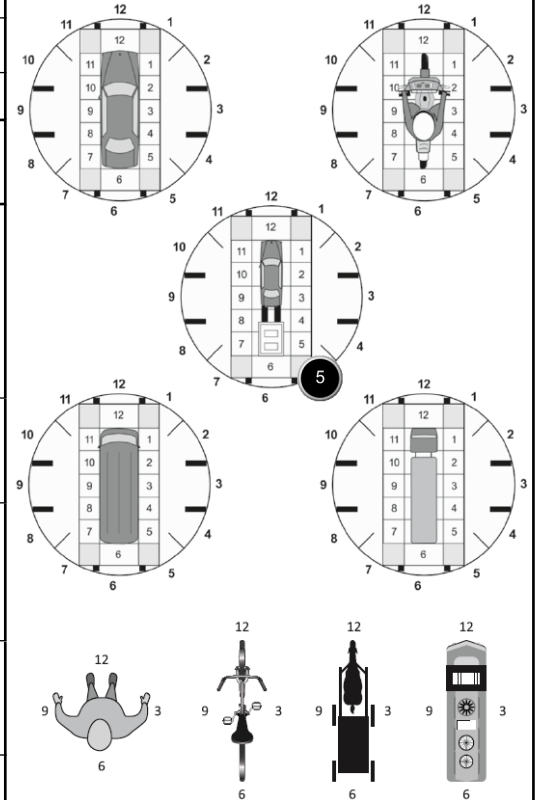

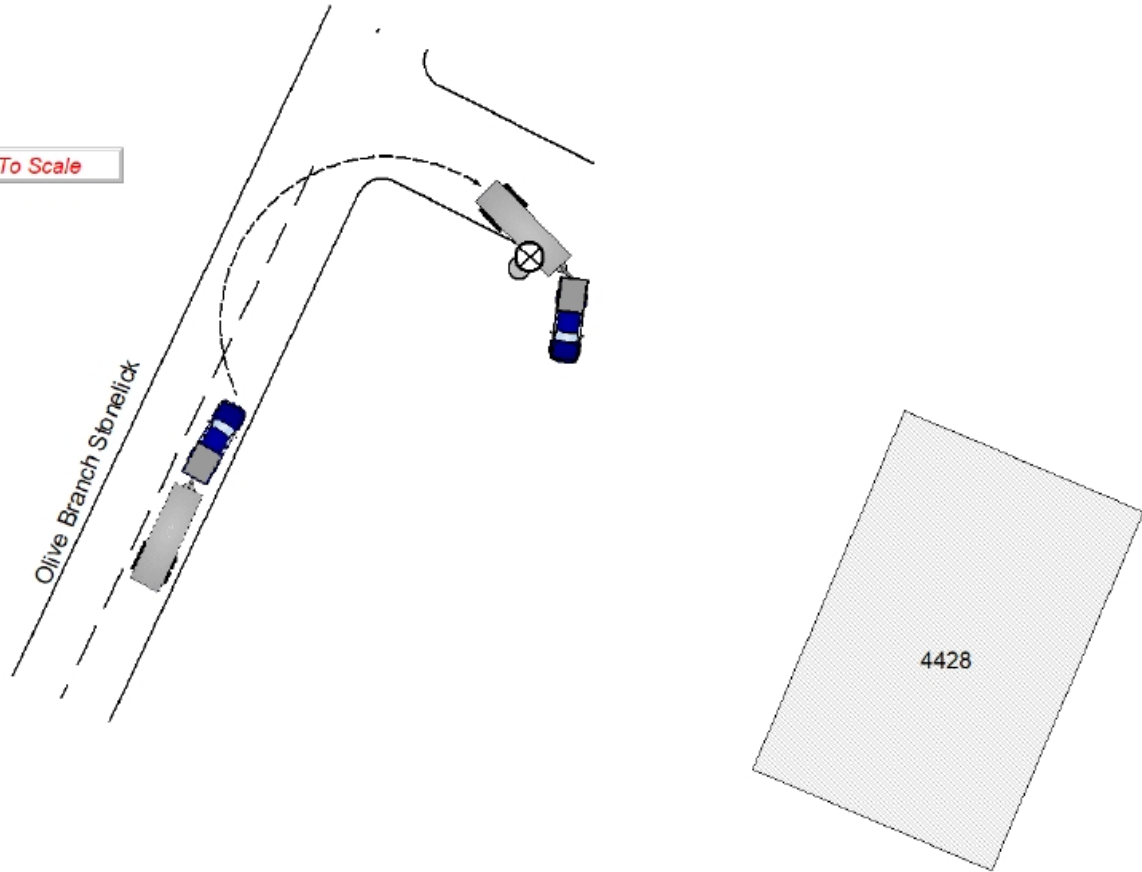
