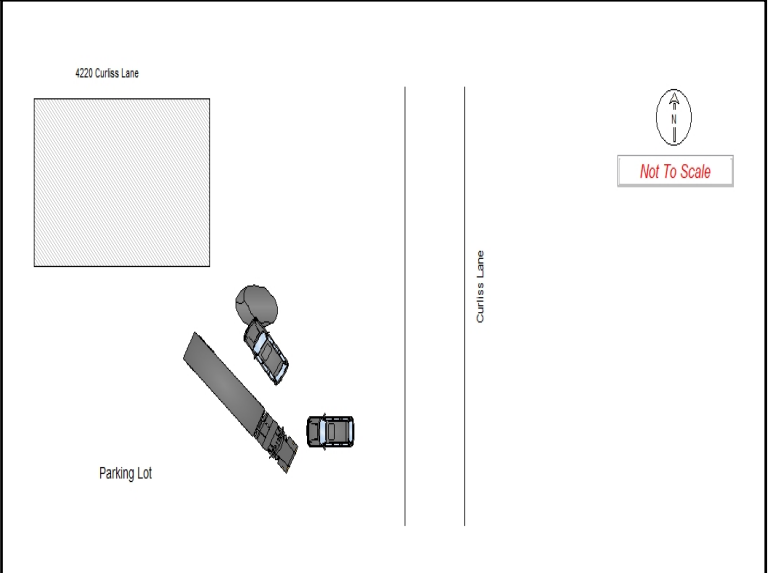

NARRATIVE
 Unit #1 was pulling away from the dock when unit #2 was pulling into the parking lot. Driver of unit #2 advised that the semi did not stop and that was when unit #2 jerked his vehicle to the right so the trailer of the semi would not strike his vehicle. Driver of unit #2 advised that when he did this he struck a large boulder causing minor damage to the passenger front bumper. I asked the driver of unit #2 if he was injured and he advised no. I made contact with the truck driver and he advised that he was making his turn away from the dock and unit #2 came up on him and did not leave him any room. The driver of unit #1 advised that unit #2 did not stop and that was when he struck the boulder. After hearing both sides I am going to declare undetermined who was at fault in the crash.

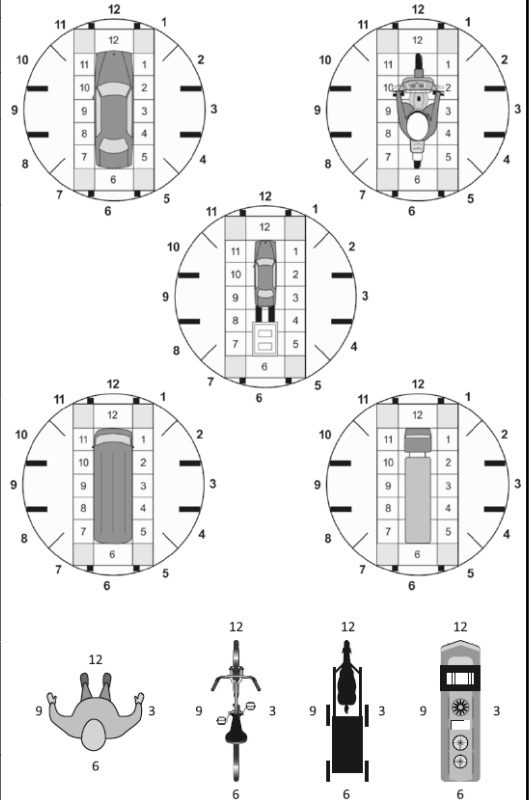

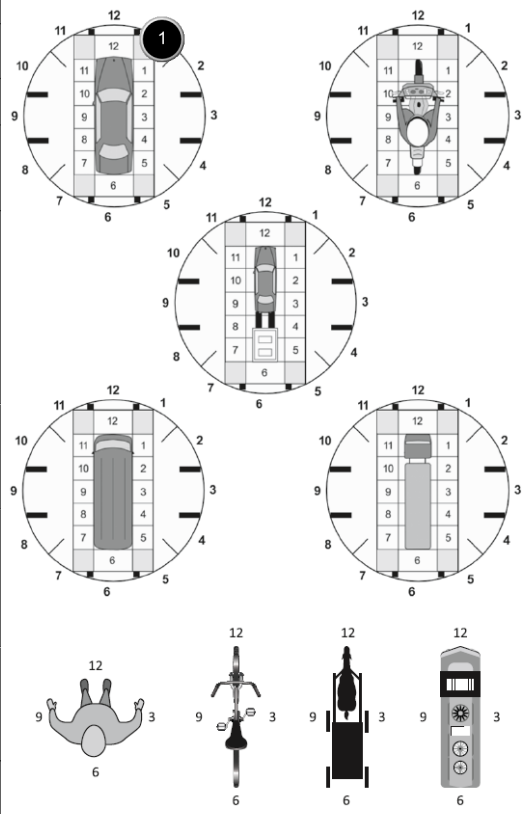

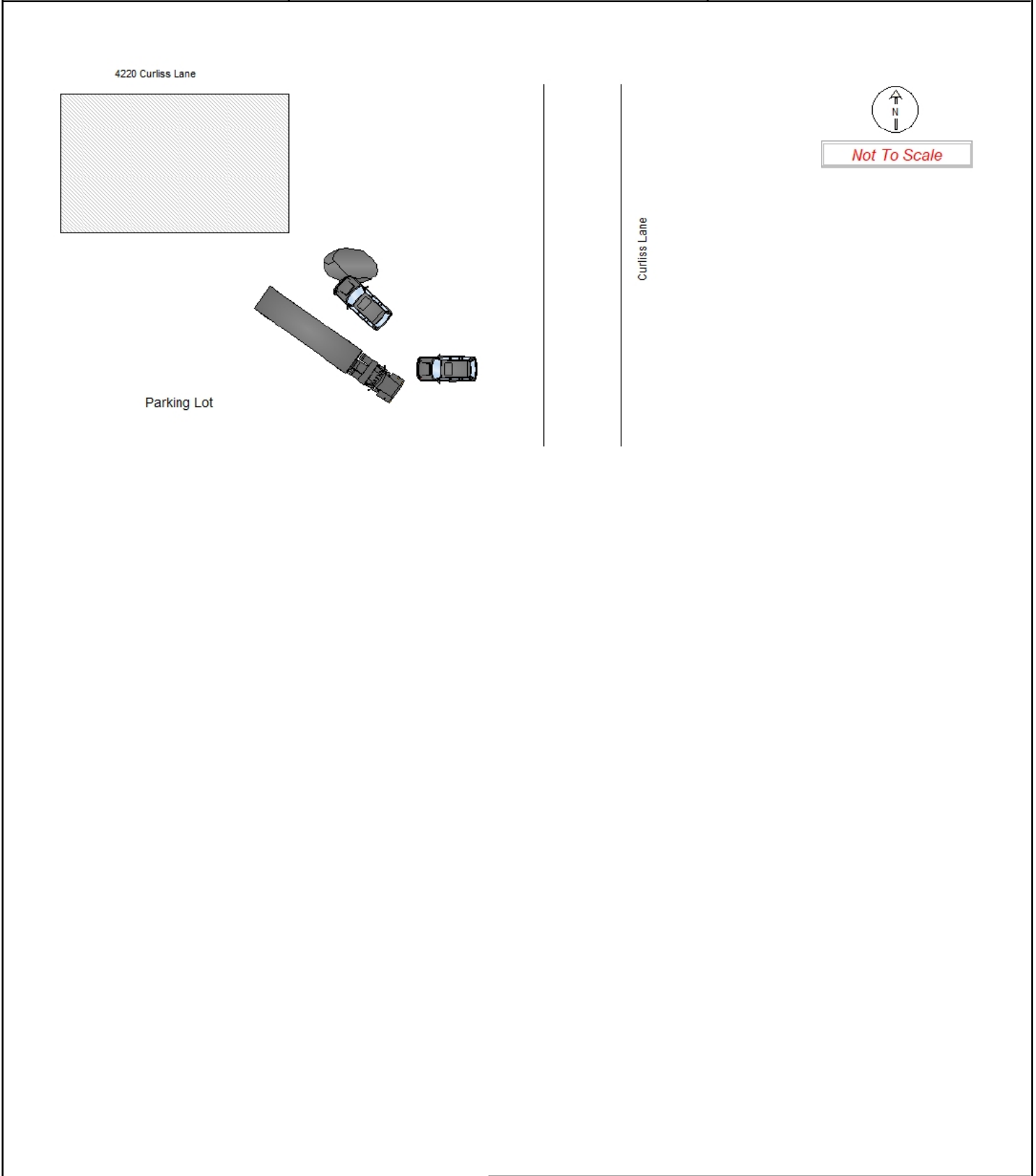
