Upon my arrival, I made contact with the complainant, Mr. Jimmy Strunk. I observed Mr. Strunk standing next to his black Mazda 4D Sedan bearing Ohio Registration JCF6416. Jimmy advised he was traveling SB on Sulphur Springs when a female subject on a bike ran into the side of his vehicle. I made contact with the female identified as Ms. Julia Robb. Julia advised she was traveling EB on Club House Dr when she approached the intersection of Sulphur Springs and Club House Dr. Julia stated she turned left onto Sulphur Springs Dr and nearly struck a vehicle that was traveling NB on Sulphur Springs. Julia advised that she attempted to hit the brakes on her bike but it was too late. Julia informed me that she attempted to swerve around the vehicle, but side swipe Jimmy's vehicle as he was traveling SB on Sulphur Springs. Julia advised that she sustained scratches and refused EMS. I observed minor scratches on the driver side of Jimmy's vehicle and the side mirror damage. I obtained photographs of the damages. 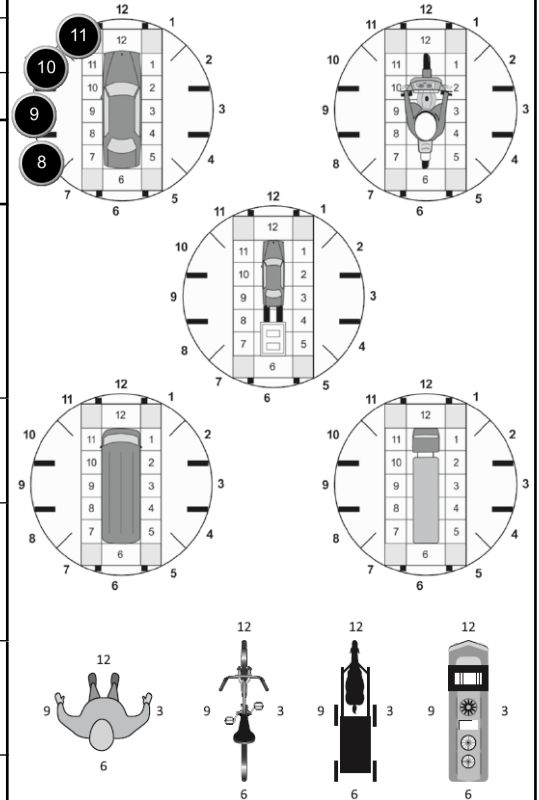

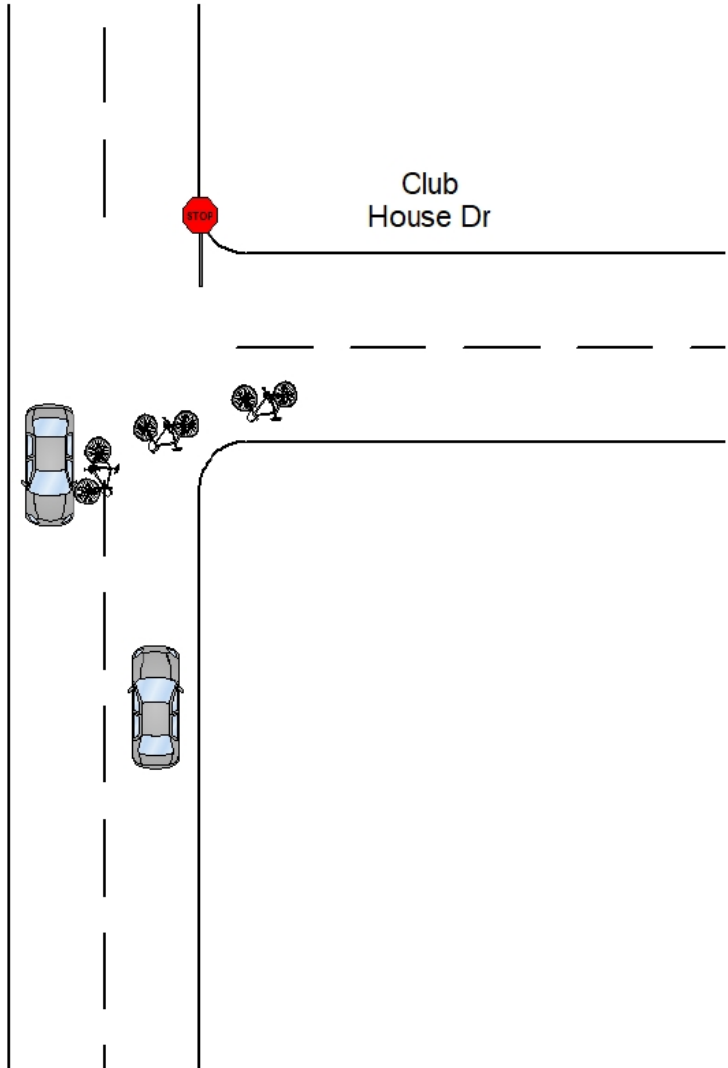
OHIO TRAFFIC ACCIDENT - OH2 DIAGRAM
