Due to extreme inclement weather with severe thunderstorms and flash flooding, the roadway had become over-run with multiple inches of moving water. The vehicle lost control and went off the south side of the roadway becoming submerged in the creek water. Unit #1 driver was able to safely exit the vehicle with no injuries reported. Roadway was shut down due to high water and to remove the vehicle.

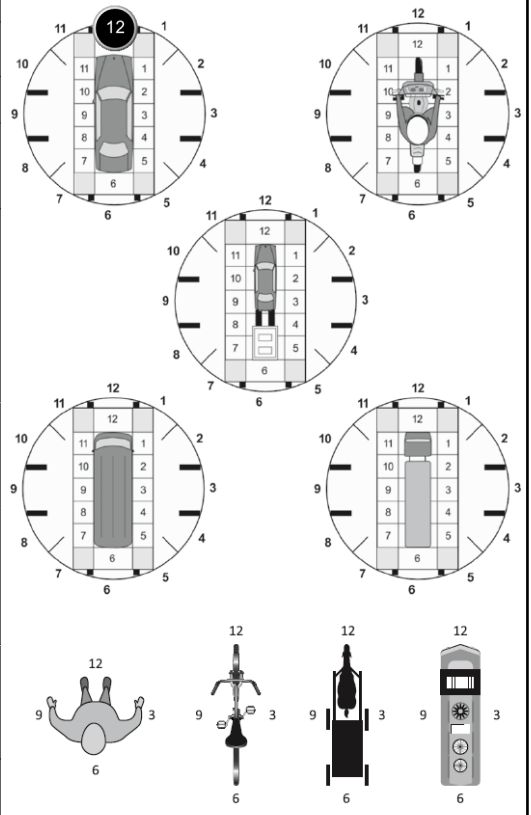

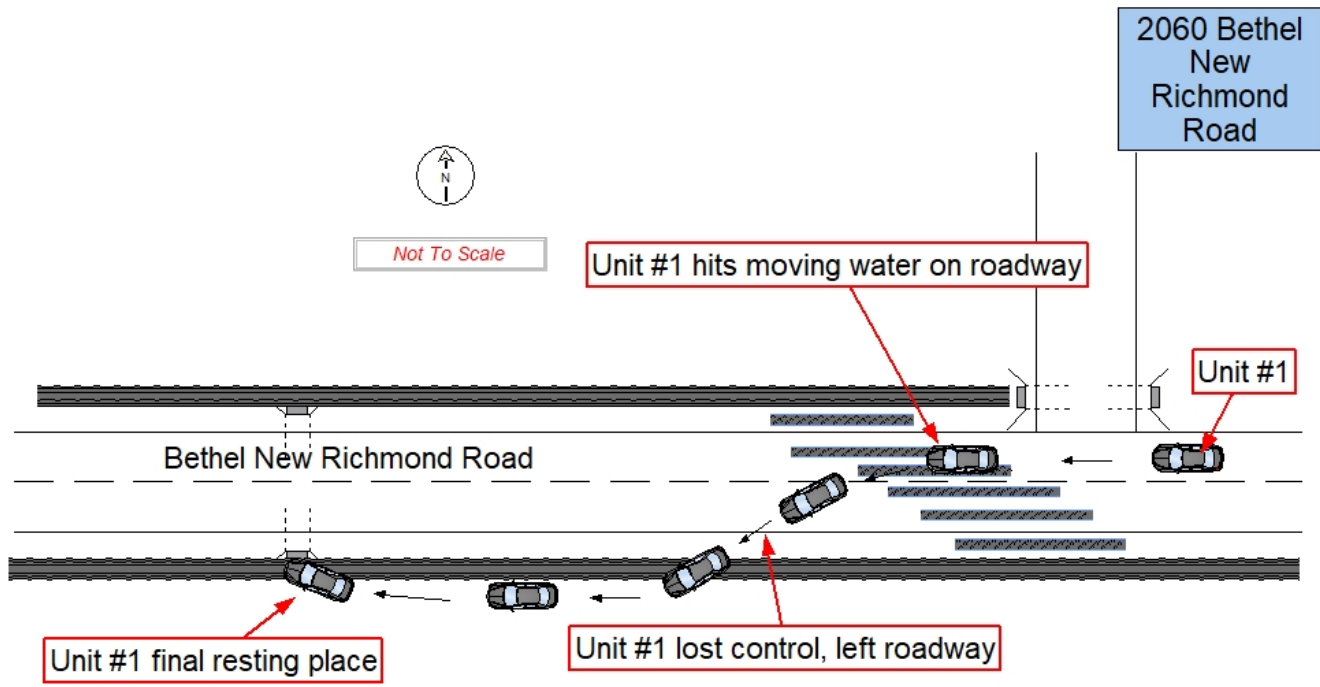
