NARRATIVE On August 12th, 2023, at 1414 hours I was dispatched to 420 Millboro Springs Dr., Batavia Township for a crash report. When I arrived on scene, I made contact with the driver of Unit 1, Alexander Watkins, who advised he was driving Sweetbriar Dr when a white work van began backing onto the roadway. He stated the work van struck his vehicle and when he spoke to the driver they became aggressive and drove away. While speaking with Mr. Watkins, the driver of Unit 2, Joshua Hughbanks, contacted the Comm. Center requesting a call. I met with Mr. Hughbanks and his passenger, James Nelson, who advised they did not strike the vehicle and when Mr. Watkins pulled up they were not sure what he was speaking about. Mr. Watkins had damage to the rear passenger side. I could not determine if any damage was caused by the rear of Mr. Hughbanks vehicle. I checked for cameras in the area and none were observed that were in working order.

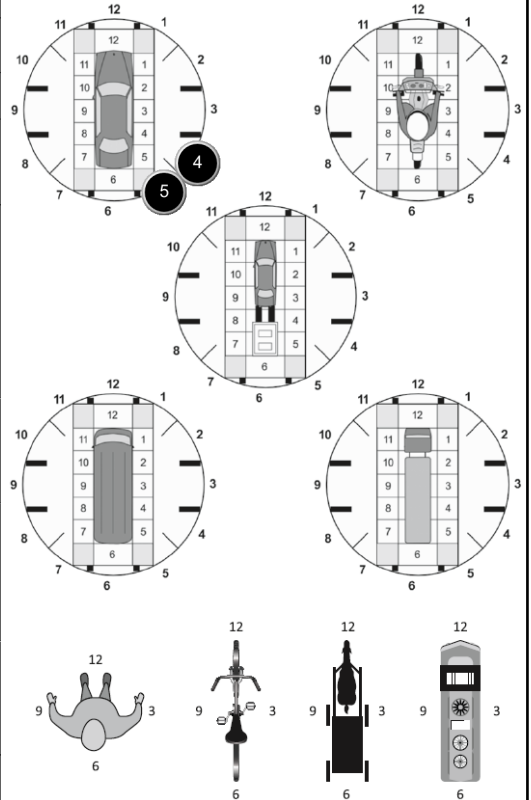

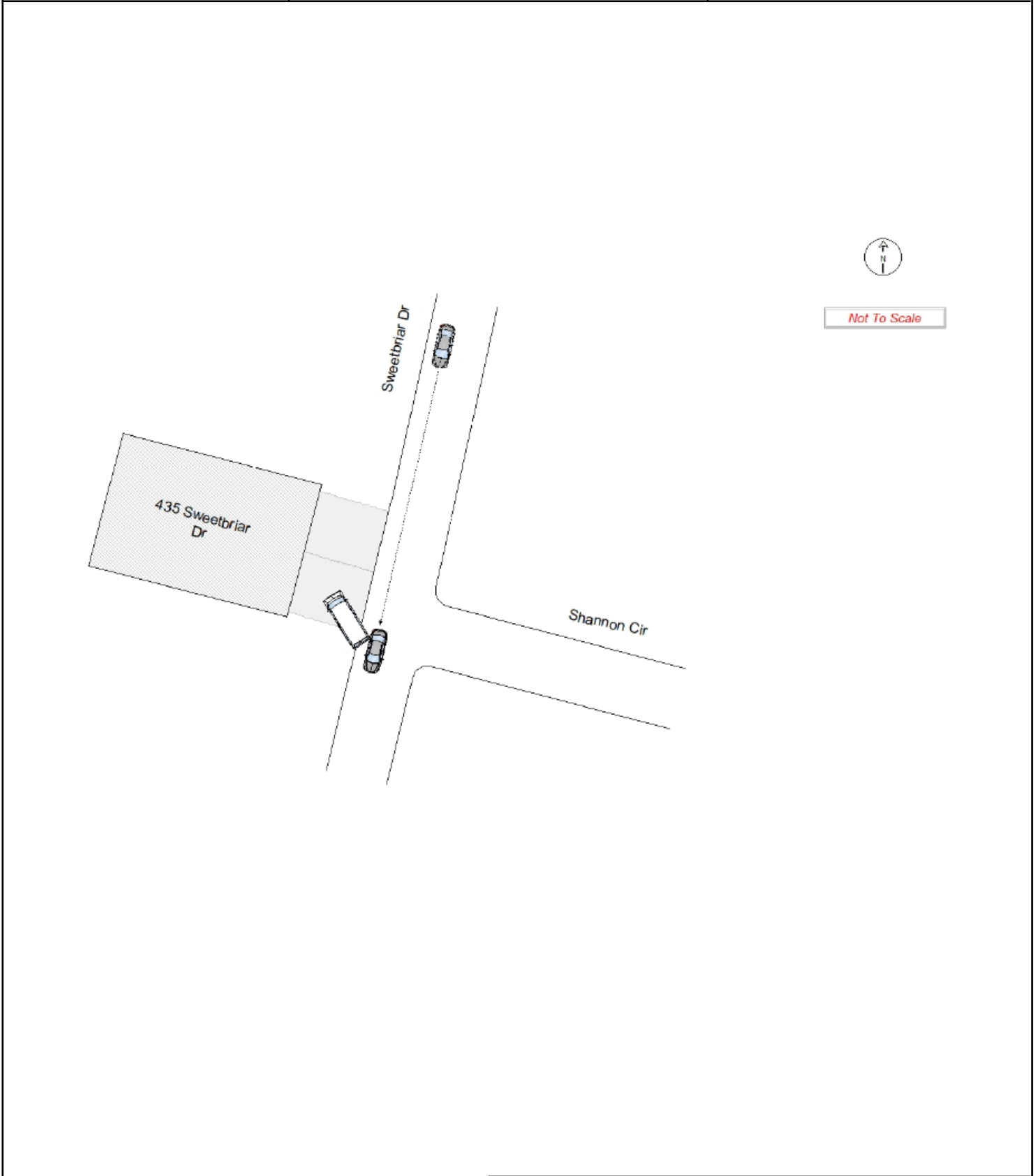
