NARRATIVE On August 16th, 2023, at 1632 hours I was patrolling the area I was flagged down by a passerby that a crash had occurred at Chapel and Apple Rd intersection. When I arrived on scene, I made contact with the driver of Unit 1, Logan Crooker, who advised he did not see Unit 2 and when he pulled into the intersection he was struck by Unit 2. I made contact with the driver of Unit 2, Jacob Oney, who stated Unit 1 did not stop at the stop sign and he began pulling into the intersection after stopping and struck Unit 1. I made contact with a witness, Mark McQuade, who advised he also observed Unit 1 run the stop sign causing the crash. Mr. McQuade advised he was on his porch when he heard the crash and saw Unit 1 strike his mailbox before coming to a stop. Due to witness statements and the manner of the collision, I cited Mr. Crooker with failure to stop at a stop sign. His vehicle was towed by Grays Towing at his request.

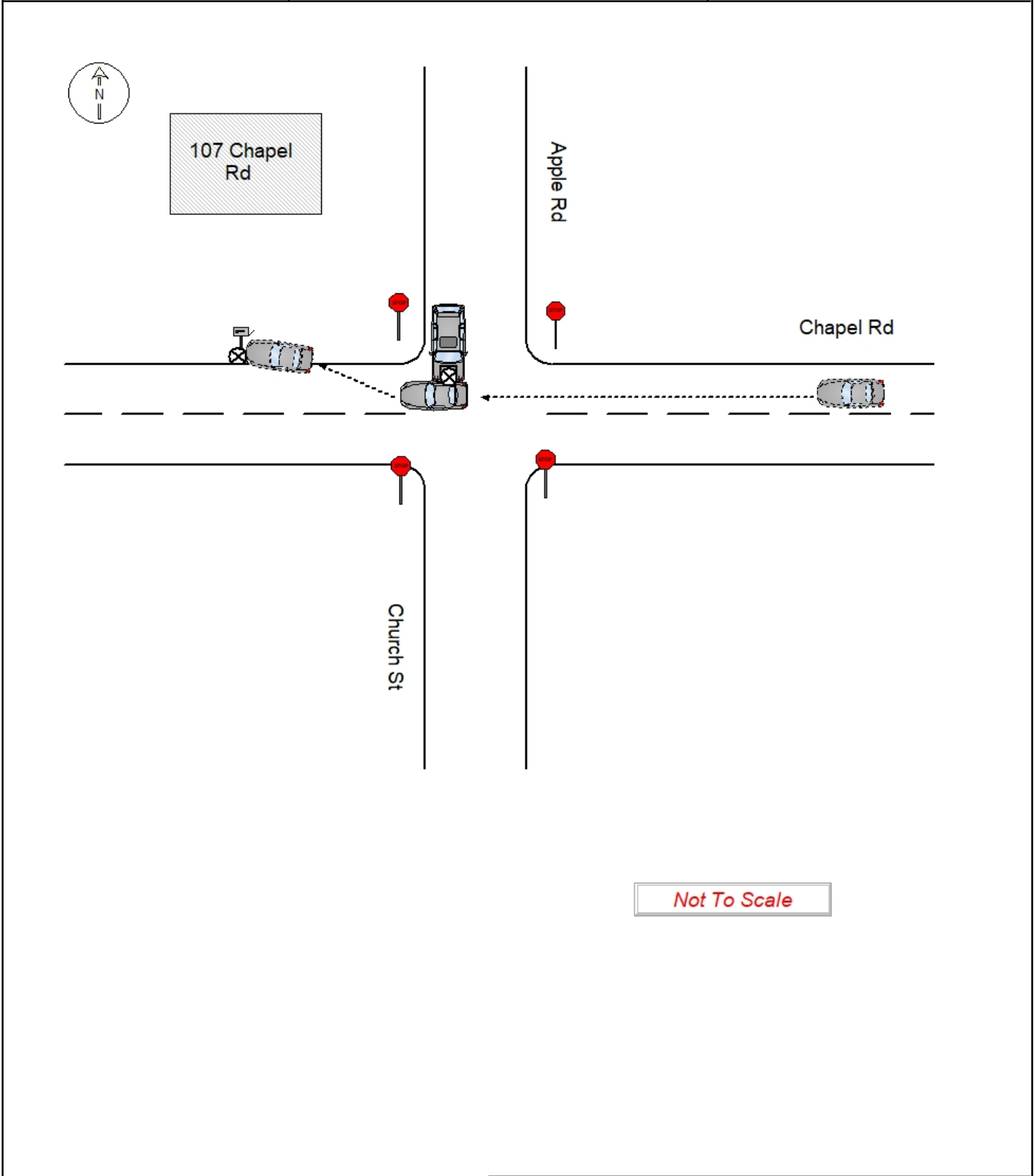
