NARRATIVE On October 7th, 2023, at 1706 hours I was dispatched to 2200 Stonelick Woods, Batavia Township for a crash on private property. When I arrived on scene, I made contact with the driver of Unit 2, Cierra Henke, who advised the crash occurred at 1100 hours. She stated the driver of Unit 1 was backing out of a parking space while she was driving down the road. She advised she attempted to brake before the vehicles struck but could not in time and her passenger side fender struck the other vehicles luggage trailer. I made contact with the driver of Unit 1, Raven Reeves, who provided a similar explanation of events. She advised she checked behind her prior to backing out and did not see the oncoming vehicle.

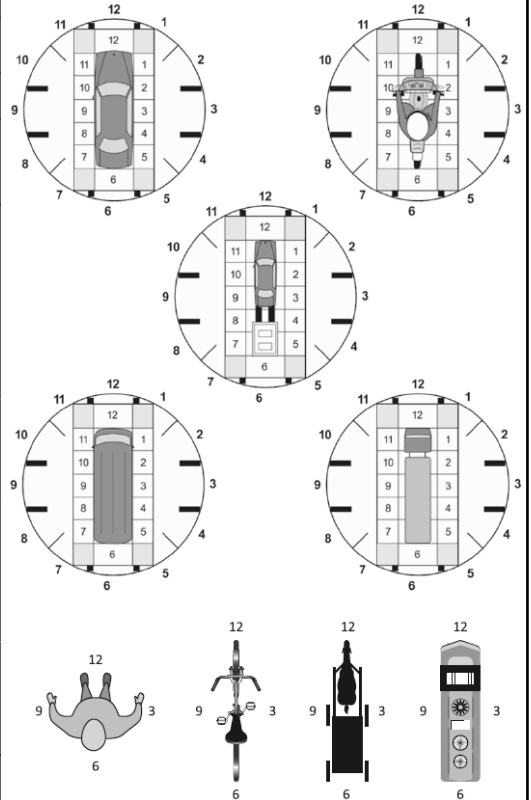

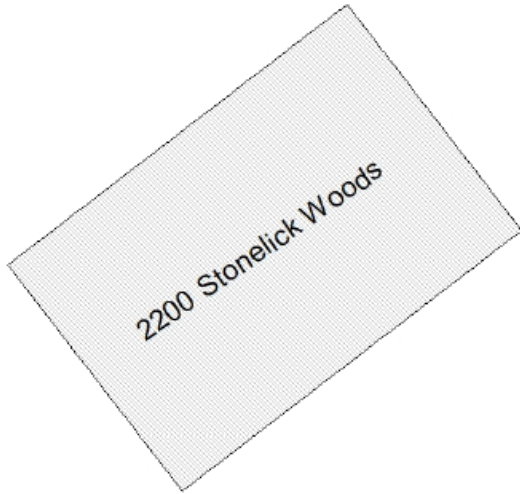

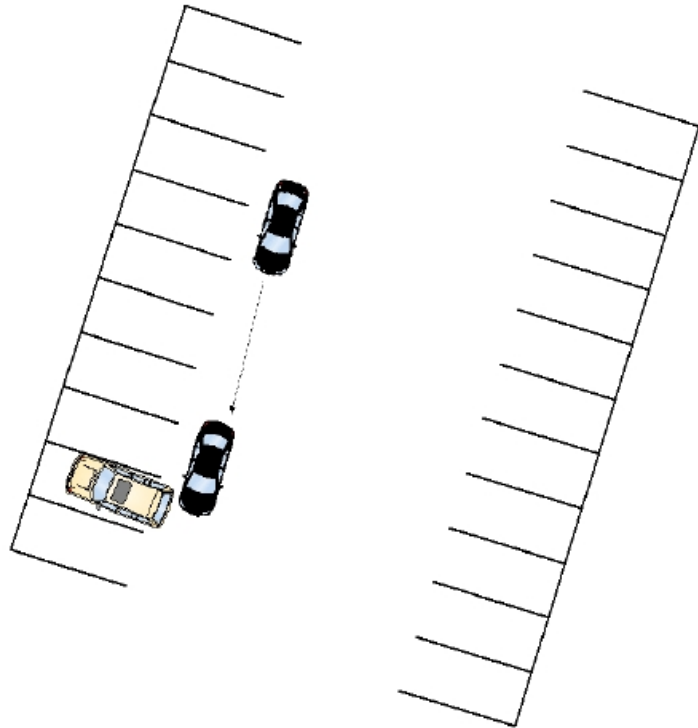
