Upon arrival there was a large container mail box that had been knocked down and already picked back up. A unknown Fedex ground transport van had backed into the mailboxes and left the scene. It is unclear if the driver is aware he hit the mailboxes but I spoke to Fedex that advised without a truck number they were not going to be able to tell who the driver was. I was unable to obtain a truck number. I took photographs at the scene. The only damage appeared to be a broken pole on the mail box holder.

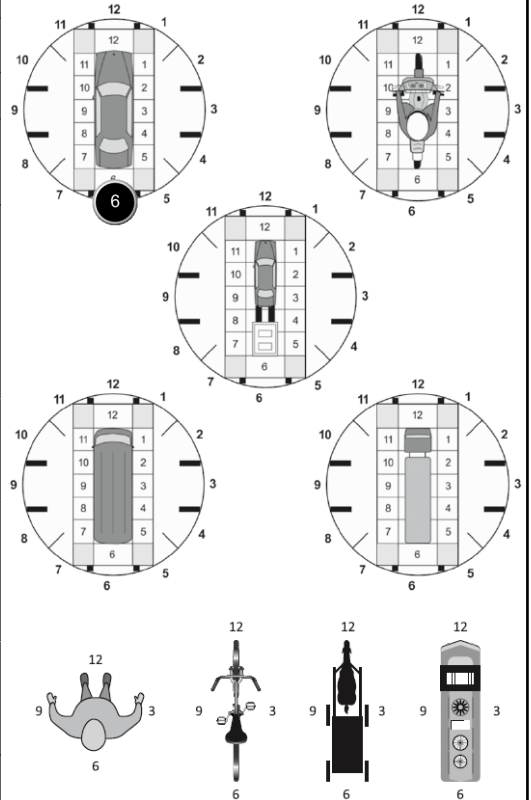

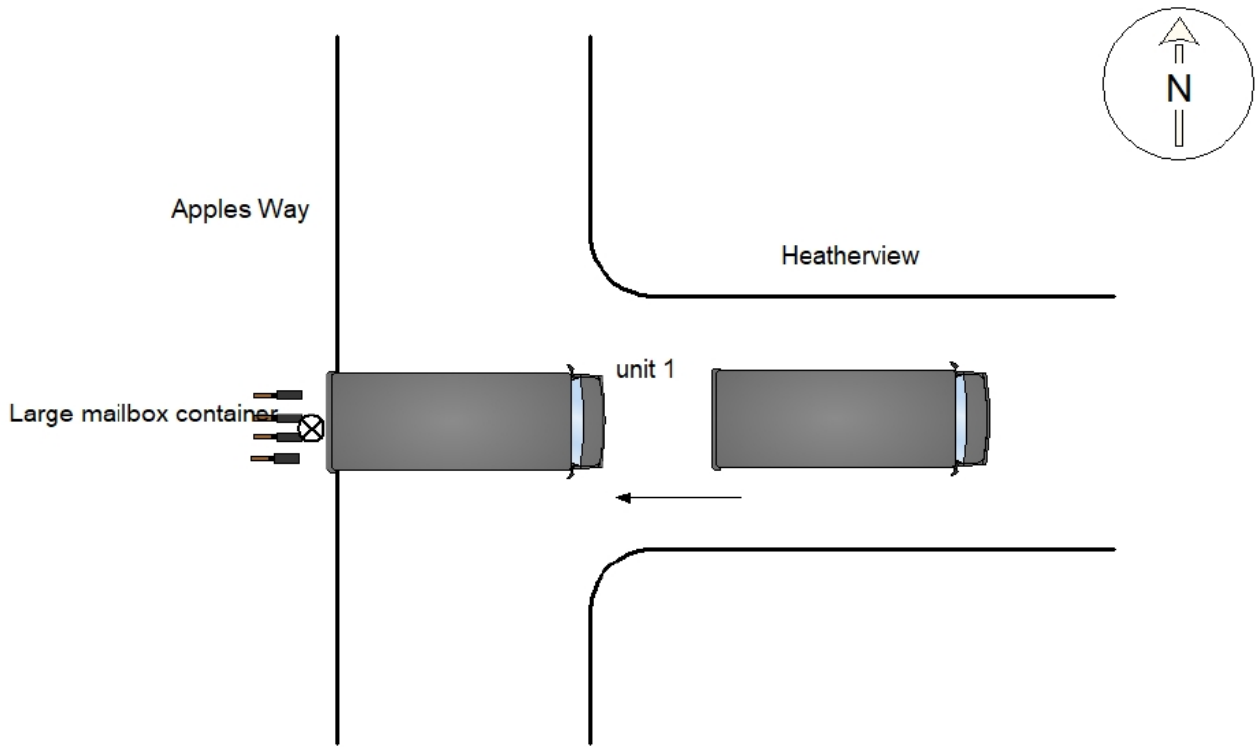
