NARRATIVE On October 18, 2023 at 2004 hours, I was dispatched to 4185 Brookdale Ct in Batavia Township for a two vehicle MVA with no injuries. The vehicles involved is a 2023 white Kia Sportage (OH-GNR2136) and a 2023 black Dodge Challenger (OH-KBC6302). Upon my arrival at 2010 hours, I made contact with both R/Os of the vehicle. Ms. Lynnette Sims (Kia) advised she was backing out of the driveway of 4185 Brookdale Ct when she backed into Mr. Robert Nooe's (Dodge) vehicle. Robert's vehicle was unoccupied and parked on the side of the roadway in front of 4184 Brookdale Ct. I observed damage the the right rear bumper on the Kia and damage to the left rear bumper of the Dodge. I was provided with both of their information for the report. While on scene, I noticed that Robert was parked on the side of the roadway that had a sign posted "no parking this side of street. Photographs were taken at the scene. 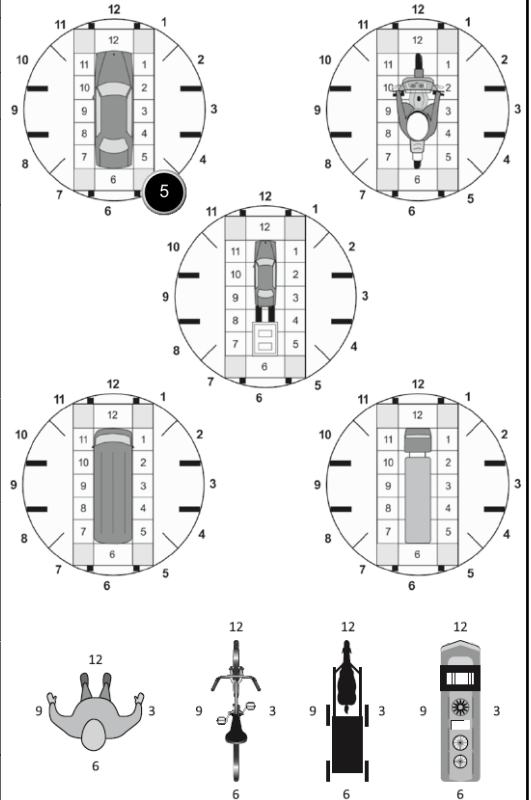

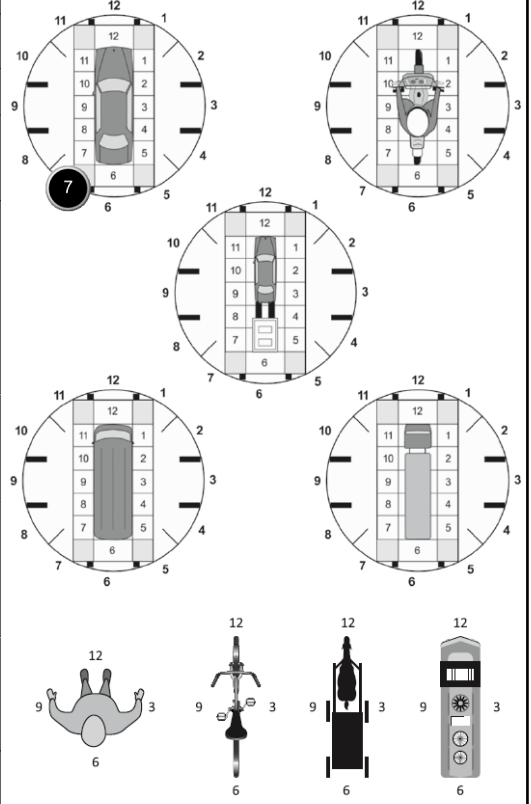

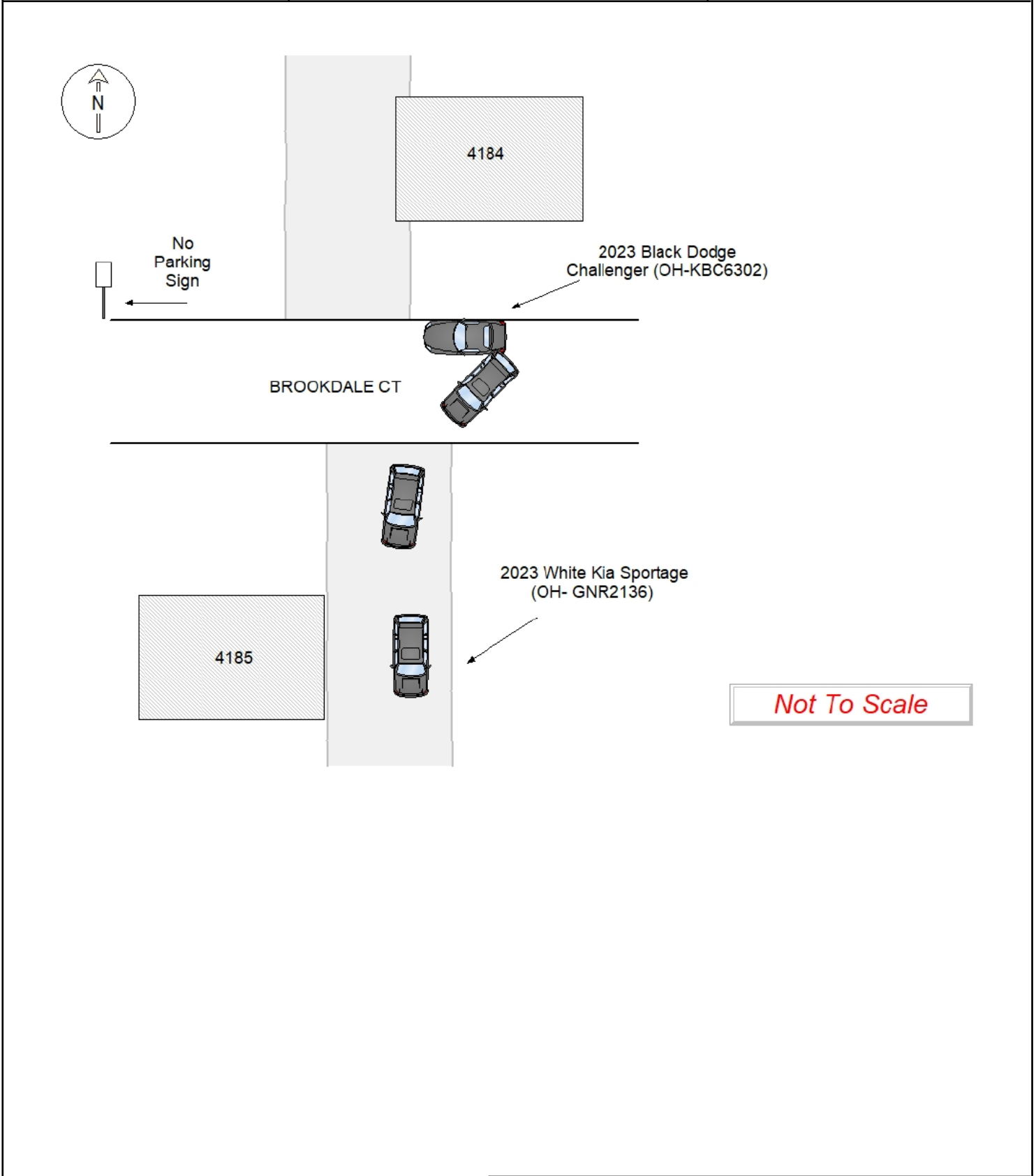
