Upon my arrival at 1823 hours, I made contact with the caller, Mr. Louis Quiles in the parking lot. Louis explained to me that he neighbor, Mr. Gregory Bingamon knocked on his door yesterday morning (10/26/2023) at 0710 hours, advising that he struck Louis' 2012 blue Ford Fusion (OH-HKQ4914) when he was pulling into a parking space in the parking lot. I observed damage to the left rear bumper of Ford Fusion. I walked over to 1388 Twin Spires Dr where I observed Gregory's 2020 blue Chevy Equinox (HMR8989) parked in the driveway. I observed damage to the right front bumper of the Chevy Equinox. I obtained photographs while on scene. I knocked on Gregory's front door and was unable to make contact. I left a business card in the door requesting him to give me a call. Louis explained to me when Gregory initially informed him about the accident Gregory did not provide his insurance information. While on scene, I was able to obtain Louis' insurance information. I will follow up with Gregory in attempt to obtain his insurance information for the report.</p>

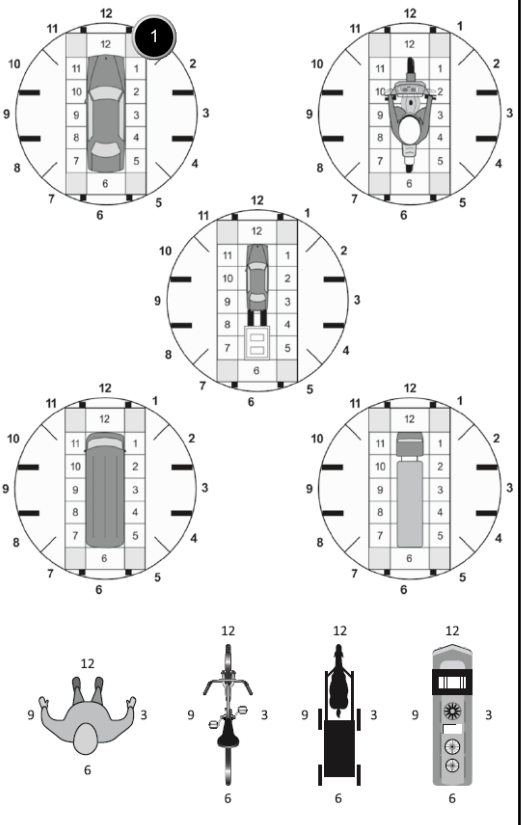

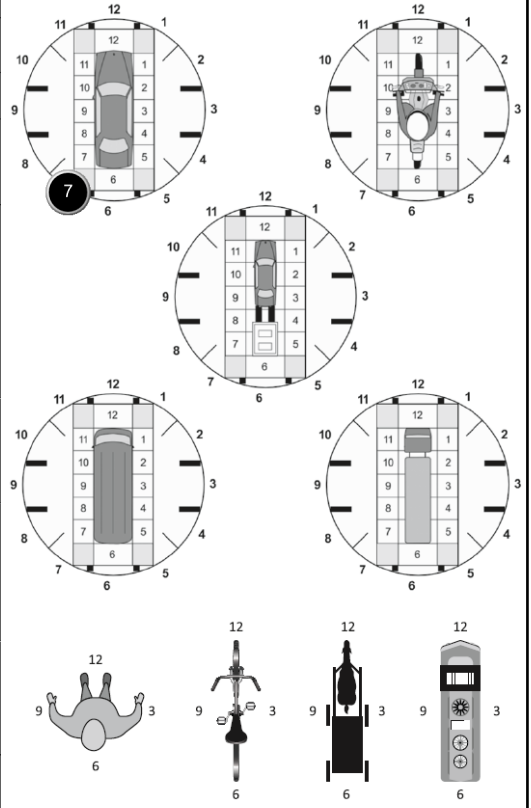

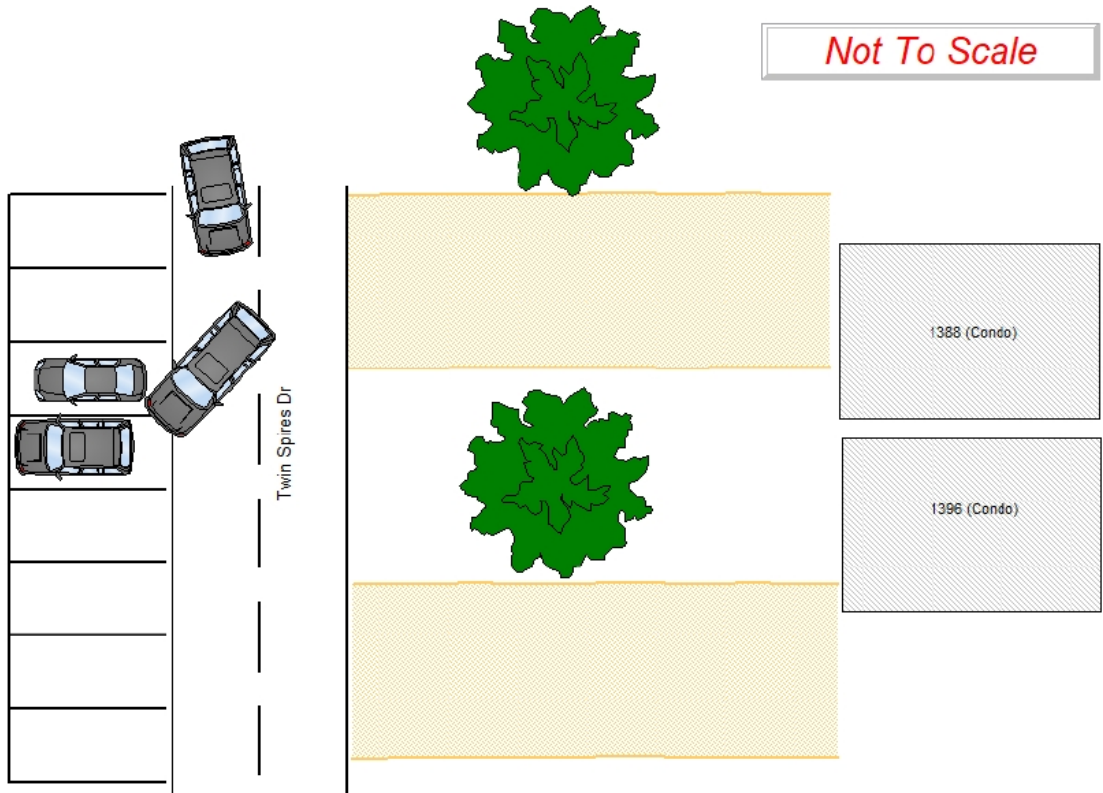
