NARRATIVE Unit #2 was traveling West on SR 32 when unit #1 changed lanes and struck unit #2 in the passenger front fender. When unit #1 struck unit #2 it sent unit #1 through the median across East bond SR 32 and came to rest in the grass on the south side of State Route 32. Driver of unit #2 had video of the crash and the driver of unit #2 advised that he and his wife were fine and they were both wearing there seat belts. Driver of unit #1 advised that he did not see unit #2 when he changed lanes. Driver of unit #1 advised that he was fine and was also wearing his seat belt. Driver of unit #1 advised that he did not have insurance on the van that he was driving. Driver of unit #1 was issued a citation for improper lane change and the vehicle was towed by Danbury towing. Photographs were also taken of the scene and unit #2 was able to driven away.

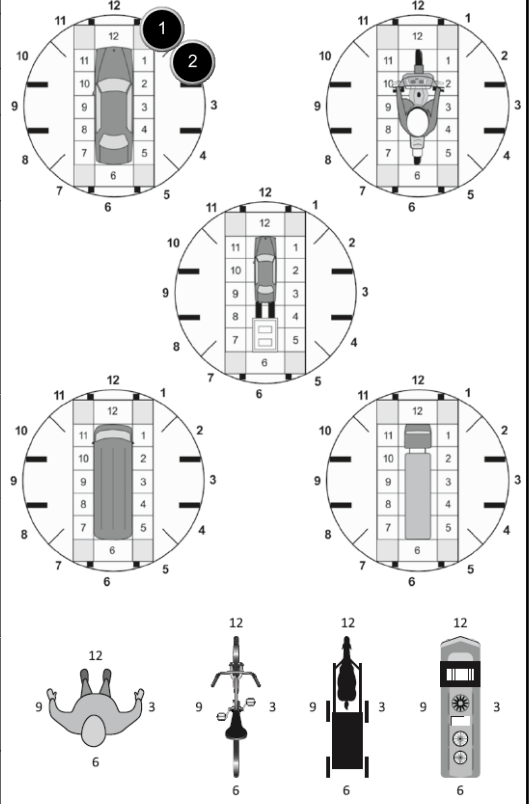

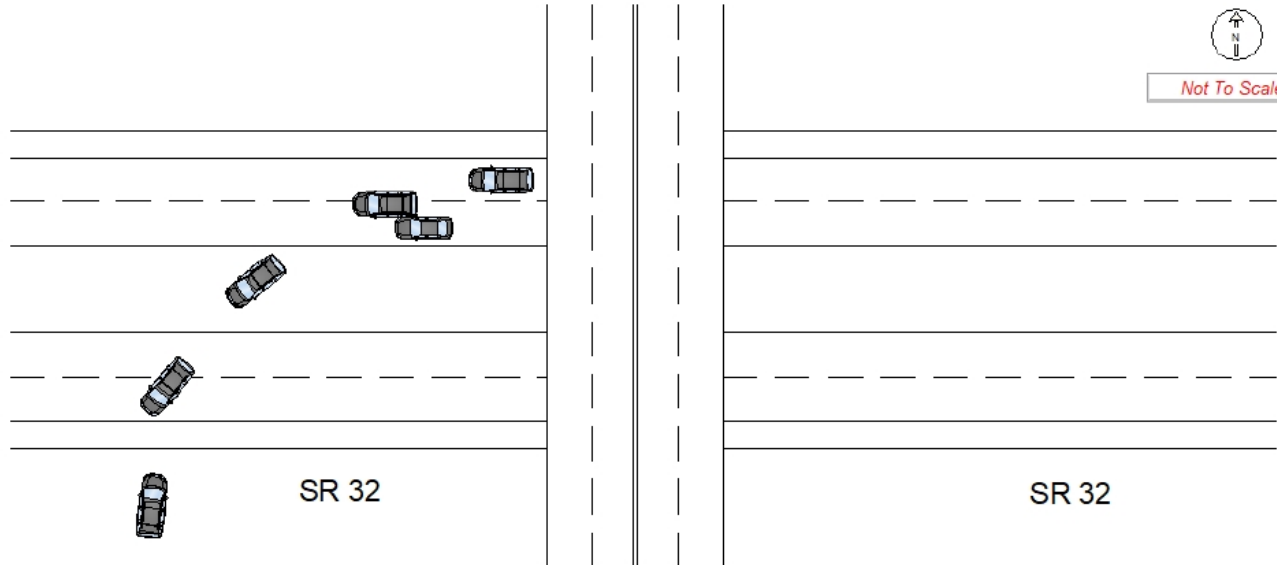
OHIO TRAFFIC ACCIDENT - OH2 DIAGRAM
