When I arrived on scene, I made contact with the driver of Unit 1, Francine Cerbantec, who advised she was driving behind Unit 2 when slowing for a turning car she was unable to fully stop and struck the rear of Unit 2. The driver of Unit 2, Jacob Dorsey, advised a car was turning in front of him when he began braking and he was struck by Unit 1.

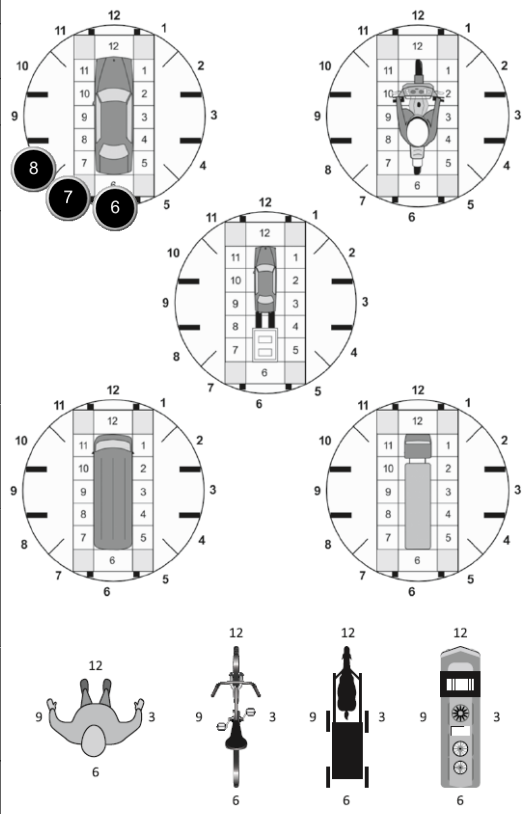

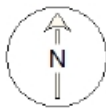
